

### **Our October Luncheon**

Our October 2025 CMC luncheon speaker was Air Force COL (Retired) Tim Tarris. Besides his very successful educational, military and civilian career, Tim talked about his 2024 "Centennial Flight" commemorating the 100th anniversary of the U.S. Army Air Service's first world circumnavigation (accomplished over the course of six months back in 1924). Tim and a younger aviator companion tried to duplicate the event (but in a more current aircraft and 100 years



later, of course . . .). Comprehensive planning worked very well until the two got to South America (Peru) where, after several days, they were stopped bureaucratically. The pair did have State Department approval and official consent from all countries enroute, but officials in Peru "changed their mind" after the flight started. As Tim said, "The situation was very frustrating and very expensive". (Needless to say) Tim and his companion never completed their own circumnavigation. Our luncheon attendees, though, were able to hear "the rest of the story" and appreciated both the excitement and frustration of the unfinished trip..

## President's message

Hello CMC members, and welcome back to our CMC monthly membership luncheons! Having a pause since last April is a long stretch of time, but our chapter has been moving forward (and continues to move forward) on many exciting and significant activities. Here are updates for your information:



**National MOAA Grant to** support EEE: As you know, we received notice last April that CMC was awarded a \$3,250 MOAA Foundation Community Outreach Grant. This grant will provide targeted support to EEE (Es-

peranza en Escalante) as we have in the past two years. EEE is a tremendous Veterans Support organization located by DM AFB; EEE provides transition support to veterans (and veteran families) from homelessness to self-sufficiency.

The three critical support areas that Suzanne Bond (EEE CEO) and I identified for CMC support include: 1) Again providing laptops (with a basic level of instruction on most effective use) to transitioning EEE residents that can be used for job searches, resume preparation, family member schoolwork, and other necessary pre- and post-transition responsibilities; 2) Providing computer desks and chairs to supplement the laptops, and; 3) Being mentors / advisors to transitioning EEE residents prior to leaving EEE. We now have volunteers to help identify, purchase and set up the laptops, computer desks and chairs. We also need volunteers, though, to help resident recipients effectively use the laptops and to mentor / advise resident recipients on resume writing, interviewing preparation and other key transition activities (on an "as needed" basis"). CMC collaboration with EEE will help ensure greater success for these transitioning residents!

**CMC Leadership Position Openings:** Your CMC leadership team members devoted significant time over the past three months to identify willing candidates who can fill our critical vacancies. Remember

that "many hands lead to light work!", so your help is essential. The role that remains unfilled is the Secretary position. Please understand that we need your help to keep this chapter thriving. If you would like to discuss the key responsibilities of the Secretary position (which are not that many!), then let's talk. Final election of new leadership members will take place at our November 2025 luncheon meeting.

MOAA's Summer Advocacy in Action (AiA) campaign is well underway, and with the Senate and House returning to Washington someday (soon?), now is the time to step up our grassroots advocacy through the Legislative Action Center (LAC).

This year's Summer AiA focuses on several critical issues:

- Major Richard Star Act (see the August Military Officer, pg. 16)
- **Military Spouse Hiring Act**
- **Currently Serving Access to Care** (with key provisions expected in the upcoming NDAA)

### **Catalina Mountains Mission Statement**

The Chapter's mission is clearly spelled out in the by-laws of the Catalina Mountains Chapter, in Section 1.2 as follows:

"The Chapter is organized, and shall be administered and operated, exclusively for the following purposes, within the meaning of Section 501(c)(19) of the Internal Revenue Code: to promote the purposes and objectives of the national Military Officers Association of America (MOAA); foster fraternal relations among active duty, former, and retired officers of the uniformed services and their reserve or national guard components; protect the rights and interests of active duty, former, retired, and reserve and national guard component personnel of the uniformed services and their dependents and survivors; provide useful services for members and their dependents and survivors; and serve the community and the nation."

## **MOAA Advocacy and the Legislative Action Center**



The optimal location to obtain the most relevant and current legislative information at national MOAA level is on the national MOAA website at: https://www.moaa.org/ . After logging into the site with your *User Name* and Password, click on the "Advocacy" link at top of the page. Here, you can click on any of the secondary links (shown to the left) in order to navigate all the most relevant and current legislative information at the national level. Much of the most important information applicable to CMC is within the "Legislative Action Center" (LAC) secondary link. Once you click on it and sign into the LAC, you will see the LAC page header shown below:



Not all CMC members are "registered" in the LAC. Please register to help bolster our support of key service member and veteran related legislative issues! NOTE: Individuals must register themselves. If you are not registered, click on the red "Sign Up" button in the upper-right corner. Then fill in the "Sign Up" information on the next page. In the "MOAA Chapter Affiliation" make sure to select "AZ12 - Catalina Mountains Chapter". Once you are registered, will see the initial LAC web page shown above.

The initial LAC web page shown is filled with valuable capability! From this page, you can "Write" your congressional representatives on all "Featured Advocacy Campaigns" items and the "MOAA's Advocacy By Issue Area" items. The emails are pre-written; all you must do is select the representatives you want the emails to go to, modify the emails (only if you want to) and hit "send". It is that easy!

A strong recommendation: After you register and sign into the LAC, DO NOT "Logout" of the LAC. If you do, the next time you enter the LAC you will have to re-register.

Please take advantage of this fantastic online capability so that your voice can be heard at national level.

### Member in the Spotlight - by Kurt McMillen

Bruce Huffman currently serves as the 1st Vice President of the Catalina Mountains Chapter (CMC). Prior to joining CMC, he completed a distinguished 31-year career of military service in both Active and Reserve components of the U.S. Army, retiring with the rank of Colonel. His primary responsibilities involved 25 years of continuous aviation focus, numerous positions in both command and staff, and accountabilities for large complex organizations.



Bruce is also a Master Army Aviator. His military awards include: The Distinguished Flying Cross, The Air Medal for Valor (3), Air Medal (19), Bronze Star, Meritorious Service Medal, Army Commendation Medal for Valor (2), Vietnamese Cross of Gallantry w/Star, Good Conduct Medal and Mississippi ARNG Medal for Heroism.

From an education perspective, Bruce earned his undergraduate degree from Embry-Riddle Aeronautical University in Professional Aeronautics and his master's degree in Instructional and Performance Technology from Boise State University.

And what has Bruce accomplished on the civilian side? He is a 50-year veteran of Business Aviation, with a record of developing and leading organizations to excellence in operational management. As the President and founder of Flight Assurance, Bruce serves as the principal consultant and has developed a unique line of process templates to provide a host of solutions to the operation of any business aircraft. Prior to founding Flight Assurance in 2009, Bruce held a variety of leadership and executive positions within the aviation community.

Bruce's past assignments have included service as: Director of Aviation at Drummond Company Inc; Director of Operations at Precision Jet Management, LLC; Director of Sales Demonstration Flight Operations for the Bombardier Business Aircraft Division responsible for both Challenger and Learjet units; Senior Vice President of Customer Operations for Avolar (UAL) where his team built the IT and operating infrastructure for a fractional aircraft start up; Senior Vice President (International), Managing Director for European Operation, and Senior Vice President for International Operations at NetJets.

Bruce's civilian credentials include an Airline Transport Pilot certificate in both fixed and rotary wing aircraft, a Certified Flight Instructor rating in both fixed and rotary wing aircraft, numerous aircraft Type ratings, and more than 16,500 flight hours.

Bruce is a member of: The National Business Aviation Association; the VHPA.; Reserve Officers Association (ROA); MOAA; Daedalians; Toastmasters International; Army Aviation Heritage Foundation; Association of the United States Army (AUSA); Phi Kappa Phi Honor Society. Bruce currently serves as the Chairman Emeritus of The Distinguished Flying Cross Society.

Lastly, Bruce is married, has two sons, and currently resides with his wife in Oracle, AZ. For more details about his considerable military and civilian experience, I am sure that Bruce would be happy to tell you all you want to know!

### **Our Next Luncheon - continued**



Phil graduated from University of California, Davis in 1963 and entered active duty in January 1966 after an educational delay for graduate school. Upon completion of flight school, he was assigned to the 335th Assault Helicopter Company in Vietnam. Phil served as an armed helicopter pilot, aircraft commander, and platoon commander through December 1967. During this time, he compiled 586 combat hours and earned a DFC, Air Medal (20 OLC), ARCOM, Presidential and Meritorious Unit citations, Vietnam Cross of Gallantry and Vietnam Service recognition.

After a year as a Tactics Instructor Pilot, Phil left active duty to return to graduate school prior to accepting an academic position with the University of California Agricultural Extension. He retired after 34+ years of service in 2002 and received Emeritus status. In 1969, Phil joined the California National Guard (later USAR) serving in various flying and command and staff positions He retired in 2000 at the rank of Colonel.

After his retirement(s), Phil and his wife Linda moved to Poulsbo, Washington. There they cruised the Pacific Northwest in the "Nordic Spirit". During their 18-year residence in Washington, Phil also served as Commodore of the Poulsbo Yacht Club, Trustee of Recreational Boaters of Washington, President of District 1 Blue Gavel, and Trustee of the
